

**RESOLUTION NO. 2012-12**

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF FOUNTAIN HILLS, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE GENERAL ELECTION HELD ON MAY 15, 2012.

WHEREAS, the Town of Fountain Hills (the "Town") did hold a General Election by mail ballot on May 15, 2012, for the purpose of the election of two Councilmembers; and

WHEREAS, the General Election returns have been presented to and have been canvassed by the Mayor and Council of the Town of Fountain Hills.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE TOWN OF FOUNTAIN HILLS as follows:**

SECTION 1. The recitals above are hereby incorporated as if fully set forth herein.

SECTION 2. The total number of registered voters was 16,074, the number ballots cast at the General Election was 5,419, the number of ballots rejected was 67, and the rate of return was 33.71%.

SECTION 3. The votes cast for the candidates for Councilmember were as follows:

SECTION 6. This Resolution shall be in full force and effect immediately upon its adoption.

SECTION 7. The Mayor, the Town Manager, the Town Clerk and the Town Attorney are hereby authorized and directed to take all steps necessary to carry out the purpose and intent of this Resolution.
