The Town of Fountain Hills (the "Town") is seeking a licensed and qualified Contractor to provide all material and labor required as described below for a period of one year.

Section I – Project Information

Contractor will perform the following landscaping services on Town-owned property, i.e., parks, parking lots and right-of-way:

- A. Installation, repair or replacement of pavers, brick and block.
- B. Removal and replacement of trees, shrubs, plants, granite mulch, river rock and boulders up to one ton.
- C. Installation, repair or replacement of landscape irrigation.

Section II – Instructions and Conditions

1. This is an indefinite quantity and indefinite delivery Agreement for Services, which shall only be provided when the Town chooses to move forward with a pending project and proper authorization and documentation have been approved. The Town does not guarantee any minimum or maximum amount of Services will be requested under this Agreement.
2. All quotations must contain the quoting firm's name and be signed by an authorized agent, officer or employee.
3. Award will be made to the Contractor whose quotation is the most advantageous to the Town.

Contractor is not responsible for repair or replacement of any acts of vandalism, damage done by others, homeowners, etc.; or extreme conditions beyond contractors control.


We do not assume responsibility for the final grade of your property. This is established by your home builder. Any modifications needed will be on a time and material basis.
