Vendor will perform all manner of electrical services for the Town to include, but not limited to: receptacle and switch repairs, lighting installation and repairs and troubleshooting electrical wiring issues. Pricing will include the hourly labor rate for normal daily business hours services and the hourly labor rate for off-hour emergency services. The quote will include the vendor's source to where a majority of the required parts or materials are purchased from. Also include any mark-up or discounts to parts or materials the Town may experience.

Section II – Instructions and Conditions

This is an indefinite quantity and indefinite delivery Agreement for Services, which shall only be provided when the Town chooses to move forward with a pending project and proper authorization and documentation have been approved. The Town does not guarantee any minimum or maximum amount of Services will be requested under this Agreement.
2. Vendors must state the manufacturer of each product quoted on in conformity with the specifications.
3. All quotations must contain the quoting firm's name and be signed by an authorized agent, officer or employee.
4. Award will be made to the Vendor whose quotation is the most advantageous to the Town.
