

AMENDMENT NUMBER ONE
TO AGREEMENT BETWEEN THE CITY OF CHANDLER
AND
VINCON ENGINEERING CONSTRUCTION, LLC
FOR RIGHT OF WAY REPAIRS
AGREEMENT NO. MU6-745-3676

This Amendment No. 1 to that certain Agreement between the City of Chandler (City) and Vincon Engineering Construction, LLC (Contractor), for Right of Way Repairs, dated June 6, 2016, is entered into this 2 day of May, 2017.

WHEREAS, the parties entered into contract for one year with provisions to extend for four (4) additional one-year terms. This is the first renewal option.

NOW THEREFORE, the parties agree as follows:

1. Section 4 of the Agreement, as amended, Price, the City shall pay to the Contractor an amount not to exceed \$120,000 Dollars (\$120,000).
2. Section 5 of the Agreement, as amended, Term, is hereby amended to extend the term of the agreement for a one-year period from June 1, 2017 through May 31, 2018.
3. All other terms, conditions and pricing of the above referenced Agreement as amended shall remain unchanged and in full force and effect.


